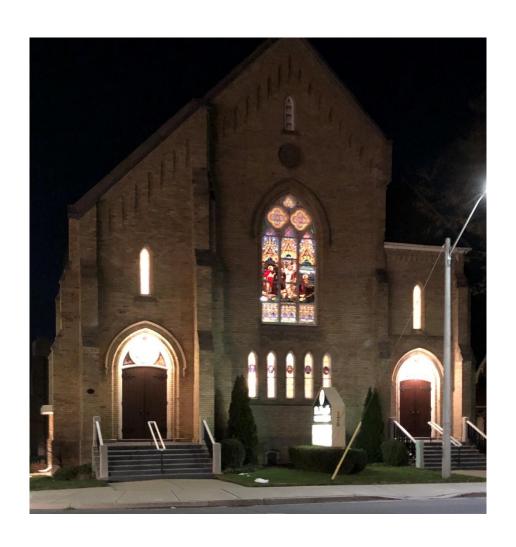

#### MINISTER'S REPORT

SINCE YOU BELONG TO CHRIST YOU HAVE RECEIVED HIS SPIRIT, WHO EQUIPS YOU WITH SPIRITUAL GIFTS

Hear The Hope Of Jesus 2025

God has called out to the whole world to put their faith in Jesus the Christ. He decided from all eternity that those who receive Jesus would become conformed to his likeness, "And those he predestined, he also called; those he called, he also justified; those he justified, he also glorified." (Romans 8:30) Since you are justified by Christ, you are called by God. Since you belong to Christ you have received His Spirit, who equips you with Spiritual gifts for works of service, to strengthen the body of Christ.

This isn't a new idea to you who have studied and heard the Word preached in this church for 1, 30, or 60 years. The message preached by Rev. Don Graham, Rev. Norman Jones, and their predecessors is a message of hope for lost people who wander in darkness. Crucially, it is **also** a message of hope for us who have been brought out of darkness into His wonderful light (1 Peter 2:9).

God rarely calls experts. As far as I can tell He has nothing against experts, but experts are rare. If sharing faith, goodness, grace and peace were left to experts, there would be very little of it to go around., ...(Hmm, the world does look as though we left God's mission to the experts!) God's plan is to use ordinary Christians in everyday goodness. With the gifts of the Spirit in the believer and the power of God in the results, this congregation and every church on earth is on the cusp of transforming the world in the name of Jesus.

If you don't recognize your gifts yet, let me assure you, you have them. Read Joel 2:28–29 and know that John declares we believe in Christ and confess Christ because we have received the Spirit of God.

Many things lead us to say, "I'm done: I'm too young/ old/ academic/ foolish/ scared/ cautious/ outspoken." But the Holy Spirit speaks hope and reveals that our disqualifiers are actually the part of our unique gifting as we trust that God can use us, especially in our weaknesses, to make a vital difference.

Throughout 2024, I have been privileged to see God's touch on many of you, as some find green pastures and others walk through hard valleys. I've shared the exhaustion that plagues so many of us as we grow older in an anxious, busy and harried world. I have witnessed God strengthening and restoring souls as saints minister to saints.

The people of God have a history where God starts a family with a nonagenarian Abram and Sarai, makes a prophet of the little child Samuel and calls an 80 year old Moses to take on Pharoah 40 years after, literally, being put out to pasture. How can it astonish us that he is still calling us today?

God *is* calling in 2025. And we can pray confidently that the Holy Spirit, which dwells in us, is pouring out his bold, refreshing, supernatural Hope upon everyone in his church.

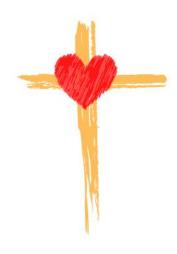

## 2024 PLAN TO PROTECT (P2P) COMMITTEE

In April of 2023, SPUCA reached out to Plan to Protect to purchase a membership plan that included a manual, certification training for an Administrator (Level One), for a Train the Trainer (Level One), online training registrations that would not expire and development of tailored SPUCA Plan to Protect policies.

It was strongly encouraged that the Administrator training occur first. This training was taken online by: Kate Kent (as the designated Administrator), Reverend Brian Wilkie, and Sue McCallum, who had initiated the process in April with the Council's direction.

Registration for the Certification Training for the Administrator was on October 12, 2024. The first online session and quiz began October 18th, 2023. The final assignment was submitted on December 29th, 2023.

The "Train the Trainer" training was also completed online by John Cronheimer. John successfully completed the certification training and started training in the spring of 2024.

A Plan to Protect Committee was established. Members of SPUCA were approached and asked to prayerfully consider being on this committee. Two meetings took place on April 29th and December 9th, 2024.

The developed Plan to Protect Policies and Procedures were initially reviewed by Reverend Brian Wilkie, John Cronheimer, Sue McCallum and Kate Kent. They were reviewed again by the Plan to Protect Committee and two corrections were made as suggested by the Committee.

SPUCA's well-reviewed and revised policies were sent for review and approval to Reith Ins. & Financial Service agents.

Faith Professional Policy 0110340FPF001.V21, ecclesiastical 2024 renewal provided abuse coverage until December 1, 2024 costing \$2,368.00.

In 2024, 41 individuals at SPUCA took the 2 hour training to work with children (0-18 and vulnerable adults) presented by SPUCA's onsite P2P Trainer. There were 3 sessions held. Included in the number are most ministry personnel and many Faith Family members/volunteers.

On November 22, 2024 we received a quote from Faith Professional 0110340QFPF009v1, *ecclesiastical* with a Policy term from December 1, 2024 to December 1, 2025 costing \$2,604.00.

Plan to Protect recommended storage has been adhered to and is inclusive of paper copies in a locked cabinet (keys to access this cabinet are currently held by Reverend Brian, Sue McCallum, Kate Kent and there is a master with the custodian), on SPUCA's INTRANET and on a USB/stick.

Laminated copies of procedures are posted on Bulletin Boards in required locations.

The annual audit completed in a review of the policies and procedures by all of the Plan to Protect Committee members result in no further changes at this time.

#### 2025 GOALS:

- 1. To review fire safety at SPUCA, as agreed at the P2P Committee meeting on December 9th, 2024 meeting.
- 2. To form a subcommittee with a number of suggested names. These individuals are to be contacted by Dan Axford (Property Chair) and Kate Kent (P2P Administrator) as Co-chairs of this committee.
- 3. To provide the two-hour certification training by John Cronheimer, to all that are interested. If any Faith Family members or new to our congregation feel the call to volunteer to help with our children or youth programming, with pastoral care and/or visitation to vulnerable adults, please contact Kate Kent, P2P Administrator or Kim Taylor, Office Administrator.
- 4. To provide recertification P2P training (up to 1hour) refresher to occur on the annual renewal time.
- 5. To maintain up-to-date criminal reference checks, every 3 years and attestation sheets, every year.

We are thankful to God for providing the people called to this important ministry, and the willingness of so many to receive the training to safely serve the children and our whole church family.

We invite the congregation to pray for wisdom as the fire safety plan is developed and implemented, and for continued vigilance in training and attention to protecting the vulnerable in our midst.

It has been a whirlwind year, but our God has been with us!
